3. The Appellant states that the information has been provided to him after lapse of 625 days. He demands that the PIO be penalized for the same. He has also filed his submission regarding the same via e-mail. Copy of the same is taken on record.

4. After hearing both the parties and perusing the case file, it is ascertained that the complete information, as available in the official record of the Respondent has been provided to the Appellant. However there are glaring systemic deficiencies in the office. Appropriate mechanism has not been provided to keep the record properly by the public authority due to which the information / request under RTI Act, 2005 are not being served properly. However, taking a lenient view, the Respondent PIO is warned to be more careful in future while dealing with the matters pertaining to the RTI Act, 2005 and act swiftly.

5. In view of the foregoing, no further cause of action is left. Hence, the Appeal case filed by the Appellant is **disposed off and closed**. Copy of the orders be sent to the parties.
