**ORDER:**

1. This order may be read with the reference of previous order dated 2.3.2022 vide which respondent PIO was directed to supply the reply/ information by 07.03.2022 and the hearing was adjourned to 19.4.2022.
2. In today's hearing, respondent, Sh. Ramesh states that information was sent to the appellant via registered post on 11.04.2022 as per the directions of the Hon'ble Commission vide orders dated 02.03.2022.
3. Appellant is absent despite being aware about the date of hearing. A copy of previous order which was sent to him returned to the Commission vide diary no. 24579 dated 29.10.2021 with the remarks 'insufficient address' but it is observed that Notice of hearing dated 06.05.2021, 22.07.2021 and Orders dated 22.07.2021 and 02.03.2022 were also sent to him on the same address as per the case file, which are not received back by the Commission.
4. After hearing the respondent and examining the case file, it is observed that respondent PIO was directed to supply information by Monday i.e. 07.03.2022 but respondent PIO failed to do so. He is directed to take care to comply of the orders passed by the Commission on time.
5. As per the case file, no communication is received from the appellant for his absence nor with regard to supply of information. Therefore, it is presumed that he does not want to pursue this case further.
6. In view of the observations noted above, the instant case is **disposed of**. Copies of this decision be sent to the parties.

**ORDER**

1. This order may be read with reference to orders dated 2.3.2022 vide which respondent PIO was directed to submit point-wise reply/information to the Commission within seven days and matter was adjourned to 19.4.2022.
2. In today's hearing, appellant states that he is not satisfied with the supplied reply/information as action taken is still pending from the respondent PIO.
3. Respondent, Sh. Baldev Singh states that reply has already been sent to the appellant comprising 12 pages. He also adds that whatever was available has already been supplied to the appellant.
4. Respondent, Ms. Jasbinder Kaur states that the appellant pleads the court that action taken could not be supplied as it is under investigation.
5. After detailed deliberations with both the parties and examining the case file, it is observed that as per orders of the Commission dated 02.03.2022, respondent PIO sent a reply dated 07.03.2022 (vide diary no.4906 dated 09.03.2022) through which he transferred RTI application to the respondent PIO, Director, Technical Education & Indl. Training, Technical Training Branch-2, Sector 36, Chandigarh but as per directions on 02.03.2022 respondent PIO has not submitted point-wise reply till date.
6. A final opportunity is given to respondent PIO to supply a point-wise reply in the shape of an affidavit in original to the appellant as per queries raised by him vide RTI application dated 31.07.2020 with a copy to the Commission within seven days from today.
7. In view of the observations noted above, the instant case is **disposed of**. Copies of this decision be sent to the parties.
