ORDER:

The complainant through RTI application dated 17.02.2020 has sought information regarding a Copy of report No.1549 dated 02.09.2019 in respect of the case of Savita Kumari V/s Rajat Sahotra under DV Act 2005 submitted by CDPO-II Amritsar to the court of Smt.Ambika Sharma JMIC District Court, Amritsar and other information as enumerated in the RTI application from the office of Department of Social Security and Development of Women and Children, Pb Chandigarh. The complainant was not satisfied with the reply of the PIO dated 28.02.2021 after which the complainant filed a complaint in the Commission on 18.03.2021.

Given the above, there was prima-facie evidence of PIO denying the information intentionally. The PIO was issued a **show-cause notice under Section 20 of the RTI Act 2005 for not supplying the information deliberately and holding the information malafidely and directed to file a reply on an affidavit.**

On the date of last hearing on 03.01.2022, both the parties were absent. The Commission received a copy of a letter dated 11.10.2021 of the Joint Director-cum-PIO O/o Director Social Security and Development of Women & Children vide which the Joint Director had directed the PIO-Child Development Project Officer, Amritsar Urban-2 to appear before the Commission on 03.01.2022 alongwith all documents.

The PIO was directed to comply with the earlier order of the Commission and appear personally before the Commission on the next date of hearing along with the reply to the show-cause notice on an affidavit. PIO to also inform who was the PIO at the time of filing of RTI and on the date of issue of show cause notice.

Hearing dated 19.04.2022:

The case has come up for hearing today through video conferencing at DAC Amritsar. Ms.Rajwinder Kaur, CDPO Amritsar is present and informed that she is the PIO in this case and has brought the information. The respondent further informed that she has just joined the duty on 19.01.2022 and earlier Smt.Meena Devi was the PIO-cum-CDPO and the delay has occurred on her part.

The complainant is absent nor is represented.

The PIO is directed to send the information to the complainant through registered post with a copy to the Commission.

Smt.Meena Kumari (earlier PIO) has however, not filed reply to the show cause notice. Smt.Meena Kumar (earlier CDPO) is given one last opportunity to file reply to the show cause notice and appear before the Commission on the next date of hearing otherwise it will be presumed that she has nothing to say on the matter and the Commission will take penal action against the PIO as per provisions of section 20 of the RTI Act.

The case is adjourned. To come up for further hearing on **05.09.2022** at 11.00 AM through video conference facility available in the office of Deputy Commissioner, Amritsar.

The case has come up for hearing today through video conferencing at DAC Faridkot. Both the parties are absent.



That the complainant through an RTI application dated 10.04.2021 has sought information regarding the detail of admission/treatment of Vaibhav Joshi s/o Sandeep Joshi along with names of doctors who attended the patient – detail of the post of Dr Wali Mohd. Action if any to be taken if he is practising at home even being in Govt. service - and other information as enumerated in the RTI application from the office of SMO Civil Hospital, Mandi Gobindgarh. The complainant was not provided with the information provided after which the complainant filed a complaint in the commission on 29.04.2021. The PIO was issued a **show cause notice under Section 20 of the RTI Act 2005 and directed to file reply on an affidavit.** The PIO was again directed to provide information to the complainant within 15 days of the receipt of the order.

That on the date of last hearing on **03.01.2022**, both the parties were absent.

The PIO also did not file reply to the show cause notice. The PIO was given one last opportunity to file reply to the show cause notice otherwise it will be presumed that the PIO has nothing to say in the matter and the Commission will take decision ex-party. The PIO is also directed to inform who was the PIO at the time of filing of RTI and on the date of issue of show cause notice.

That the case has come up for **hearing today through video** conferencing at DAC Patiala. The PIO is absent on 3rd consecutive hearing nor has filed reply to the show cause notice. There is nothing on record which shows that the RTI application has been attended to by the PIO.

Keeping the above-mentioned facts of the case, it is clear that the PIO-SMO Civl Hospital, Mandi Gobindgarh, District Fatehgarh Sahib is flouting the spirit of the RTI Act continuously. The PIO has not only shown utter disregard for the Commission's repeated orders to provide the information but has shown willful stubbornness in not appearing before the commission despite various orders of the Commission.
