ORDER:

The appellant through RTI application dated 30.01.2020 has sought information regarding recruitment of 9998 TTT against advertisement dated 02.09.2007 – details of applicants applied for the post under SC category – SC certificate of the applicants – experience certificates of the applicant – name of the officer who verified the experience certificates and other information from the office of DEO (EE) SBS Nagar, Nawanshahar. The appellant was not satisfied with the information provided by the PIO vide letter dated 14.03.2020 after which the appellant filed first appeal before the First Appellate Authority on 10.03.2020 which took no decision on the appeal.

The case last came up for hearing on 08.12.2020 through video conferencing at DAC Hoshiarpur. Both the parties were absent. The commission received an email from the appellant stating that the PIO has not supplied the complete information on point-IV.

The PIO was directed to remove the discrepancy in point-IV and provide complete information to the appellant.

Hearing dated 19.05.2021:

The case has come up for hearing today through video conferencing at DAC Hoshiarpur. The respondent present pleaded that complete information regarding point-IV has already been provided to the appellant and no further information is available.

The appellant is absent on 2nd consecutive hearing to pursue his case.

The case is **disposed of and closed** for non-pursuance by the appellant.
