3. On this, representative of the complainant, Sh. Rajesh Kumar states that only two pages have been received from the respondent PIO and presented before the Commission during the hearing.

4. After hearing both the parties and examining the case file, It is also observed that respondent PIO was absent on the previous hearings held on 18.02.2019, 25.03.2019 and 01.05.2019. On hearing held on 01.05.2019, Show Cause notice was issued to the respondent PIO and matter was adjourned for further hearing on 19.06.2019.

On hearing held on 19.06.2019, Sh. Brij Mohan (Deputy DEO) was appeared and stated that no Public Information Officer has been appointed in the office of DEO (SE), Fazilka. Respondent was advised to supply the requisite information to the complainant and compensation amounting Rs. 1,500/- was awarded to the complainant vide order dated 19.06.2019 and matter was adjourned for further hearing on 29.07.2019.

On hearing 29.07.2019, last opportunity was given to the respondent PIO to appear in person to clear the facts of this case but respondent PIO failed to represent this case today.

It is observed that respondent, Sh. Captain Singh does not aware about the facts of this case.

Complaint Case No.: 1131 of 2018

5. In view of the defying attitude of the respondent PIO neither attending the court nor submitting any explanation for the delay in supplying the information within the time schedule as prescribed under the RTI Act 2005, the court comes to a logical conclusion that it is a fit case for the imposition of penalty amounting to Rs. 25,000/- (Rupees Twenty Five thousand only) on the PIO. Therefore, taking a lenient view, I impose a penalty of **Rs. 5,000/- (Rs. Five Thousand Only) on the concerned respondent PIO, Office of DEO (SE), Fazilka.** The Drawing and Disbursing Officer of the office of the DEO (SE), Fazilka is directed to deduct the amount of penalty of Rs. 5,000/- from the salary of the concerned respondent PIO and deposited in the State Treasury in the following Head of Account and to report its compliance to the Commission:-
