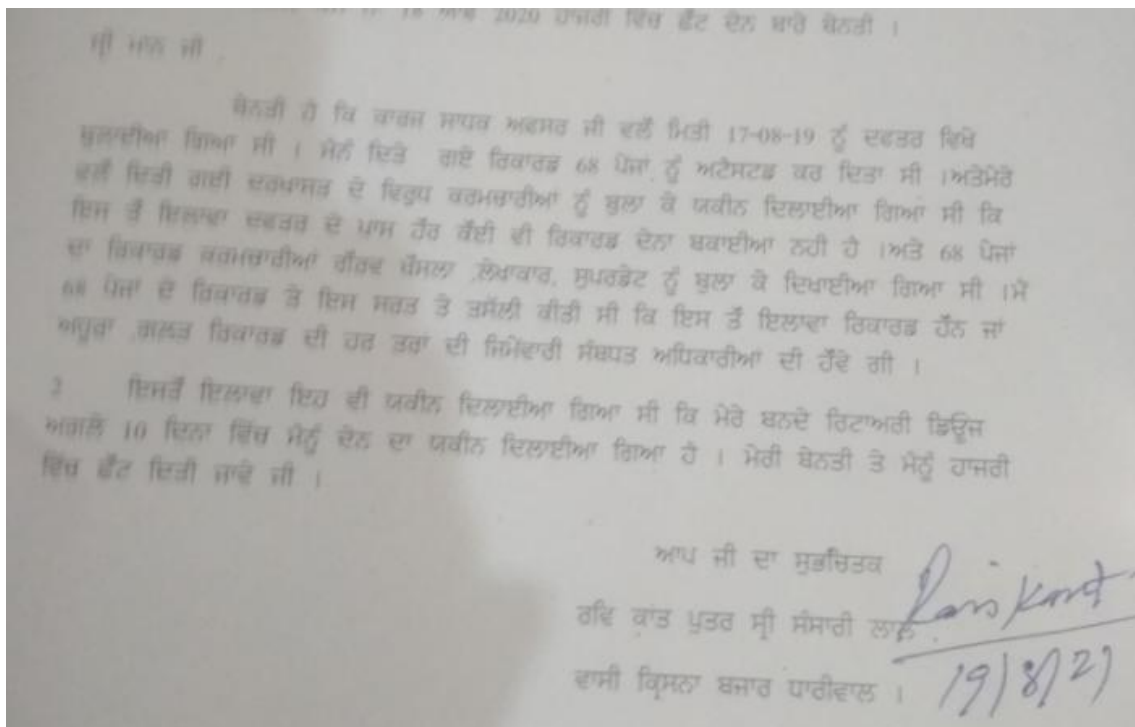

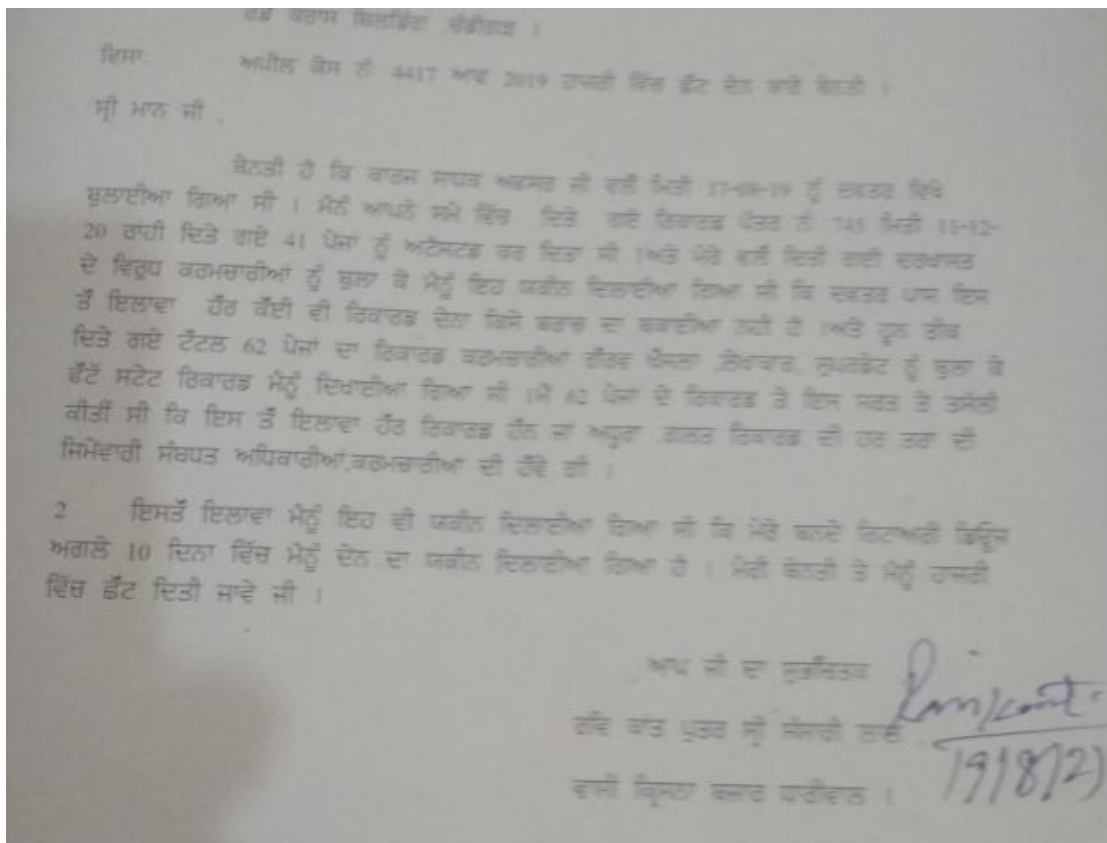

ORDER:

This case may be read with the reference of previous order dated 16.08.2021 vide which both the parties (appellant and respondent PIO concerned) were directed to remain present during the proceedings of the instant appeal-case on the next date of hearing positively fixed in the office of State Information Commission, Punjab, so that facts of this case could be cleared or the case would be decided on merits.

An opportunity was given to the Respondent / PIO concerned to bring the copy of the information (which was already supplied to the appellant) with the relevant official record to the Commission on the next date of hearing i.e. today.

In today's hearing, the Appellant, Sh. Charanjit Singh is absent but an email dated 16.08.2021 has been received in the Commission vide which the Appellant has written that his age is 71 years and he is suffering from Hepatitis – C and further request that he would not be able to appear in the Commission and request for the information from the Department through registered post.
