

2. The Appellant reiterates his earlier stand that no information has been provided to him by the Respondent – PIO till date.

3. The respondent-PIO Shri Partap Singh, BDPO, Fazilka is absent for the **6**<sup>th</sup> **time consecutively.** The respondent-PIO neither has bothered to file an affidavit duly attested by the Notary in reply to the Show Cause Notice issued to him vide order dated 03.06.2019 nor has supplied the demanded information to Appellant.

4. The facts narrated above clearly reveal that there is **a delay of about 11 months** not supplying the information to the appellant, which is definitely on a high side and cannot be given a go by. Besides, the respondent BDPO, Fazilka, seems totally unmindful and indifferent to the orders issued by the Commission on a number of occasions and openly defied them. Thus, the Commission draws the inference that the PIO, without any reasonable cause, has refused to furnish the information to the appellant and has malafidily denied him the same and thus, has rendered himself liable for punishment as provided under the RTI Act, 2005. Though he was given a number of opportunities to explain his position in connection with the Show Cause Notice issued to him under Section 20(1) of the Act ibid, he failed to come out with a satisfactory reply. In these circumstances, **Shri Partap Singh, BDPO, Fazilka** is held guilty of default on the above score. The facts of this case also prove beyond any doubt that the respondent PIO concerned does not deserve any kind of leniency. Hence, in exercise of the powers conferred by Section 20(1) of the RTI

Act, 2005, **a penalty to the tune of Rs. 10,000/- (Rupees Ten thousand only)** is imposed upon Shri Partap Singh, BDPO, Fazilka to be deducted from his salary which is to be deposited in the State Treasury under the relevant head. An attested copy of the receipted challan is also directed to be present before the Commission on the next date of hearing.

5. After going through the facts available on the record and in view of the request of the appellant for **awarding him a suitable compensation**, it is true that no information has been supplied to the appellant after 11 months. During this period, he has attended **5 (five)** hearings in the Commission while travelling from **Fazilka to Sector-16**, **Chandigarh and back.** In view of the loss and detriment suffered by him during this long period in obtaining the information in the instant case, I find full justification in awarding him a suitable compensation. Therefore, in exercise of the powers conferred by Section 19(8)(b) of the RTI Act, 2005, a compensation of Rs.4000/- (Rupees Four Thousand only) is awarded to Shri Hardeep Singh, appellant, to be paid by the Public Authority i.e. through Bank Draft, within 30 days and confirmation to this effect will be furnished to the Commission.
