2. However, the respondent-Public Information Officer categorically mentioned the decision of CWP No. 4787 of 2011 Hon'ble Punjab and Haryana High Court vide his submissions, which has been diarized in the

Commission vide No. 576 dated 11.1.2022. Also the relevant portion of the judgement mentioned by the respondent-Public Information Officer is reproduced below:-

“...it was ruled that the citizens have to attach the copies of their identity proofs along with the application seeking information under RTI Act. The High Court found that in many cases, the RTI applicants were not identifiable and hence the step was necessary to ensure that only the genuine persons get the information.”

He also states that according to the decision, the reply was also sent to the appellant within 30 days and he further requested to close the case accordingly.

4. After hearing the parties and going through the case file, it has ascertained that the appellant attached the copy of aadhar card along with the 2nd appeal filed in the Commission. In view of the above, the appellant is hereby directed to submit a copy of self attested ID proof to the respondent Public Information Officer within two weeks. Accordingly, the respondent Public Information Officer is directed to provide the sought information to the appellant on receipt of the self attested ID proof from the appellant within four weeks with a copy to the Commission. Also a copy of aadhar Card is being sent to the respondent Public Information Officer along with this order. Keeping in view the above, the case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within five weeks in case he does not receive the information after the submissions of self attested ID proof.
