On the last date of hearing, held on 31.08.2020, Sh. Jatinder Pal Singh, Asstt. Labour Commissioner-cum-PIO, appeared in person and sought an adjournment in this case to supply the complete information to appellant. Last and final opportunity was given to the respondent-PIO concerned to supply the certified copies of the required information to the appellant as per queries raised by her through RTI request,

The appellant, Ms. Swaranjeet Kaur, who appeared in person in today's hearing, states that as directed vide orders dated 31.08.2020, no information has been supplied to her by the respondent PIO.

In the instant appeal case, on the hearing held on 04.09.2019, a compensation of Rs. 2000/- was awarded to the appellant and on the hearing, held on 28.11.2019 the compensation amount was enhanced from Rs. 2000/- to Rs. 5000/- for non-compliance of the order dated 04.09.2019.

On the hearing, held on 22.01.2020, Sh. Jaswinder Singh, who appeared on behalf of the appellant, Ms. Swaranjeet Kaur, had refused to take Rs. 5000/-, which was awarded as compensation amount vide orders dated 28.11.2019 as he requires only information. He also submitted a written-submission dated 22.01.2020 during the hearing, stating that he is not willing to take Rs. 5000/- which was awarded as compensation amount vide orders dated 28.11.2019. It is placed in the case-file.

In view of the refusal of the appellant to take compensation amount of Rs. 5000/-, which was awarded to him vide orders dated 28.11.2019, the directions passed by the Commission vide orders dated 28.11.2019 regarding compensation, were dropped.

In today's hearing i. e. 19.10.2020, neither the respondent PIO nor any of his representative is present. He has neither sent any intimation regarding his non-availability nor sent any document, which shows that the information has been supplied to the appellant which reflects that he is trying to delay in supplying the required information to the information-seeker. The Commission took a serious view of this casual approach of the respondent PIO concerned.

For making inordinate delay in supplying the requisite information to the information-seeker under Section 20 (1) of the RTI Act, a penalty of Rs. 10,000/- (Rupees Ten Thousand Only) is imposed upon the concerned Public Information Officer of office of Asstt. Labour Commissioner S.A.S. Nagar (Mohali) (Workman Compensation Commission S.A.S. Nagar. A copy of this order be sent to him through registered post.

The amount of penalty will be deposited in the treasury of Punjab Government under the head.....
