1. The RTI application is dated **27.8.2020** vide which the appellant has sought voluminous information **regarding the costs of cleaning sewer lines, logbook of the Jet Machine, expenditure on fuel, details of contractor etc.,** as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **7.10.2020** and Second Appeal was filed in the Commission on **28.12.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **26.8.2021**.

2. Both parties absent without intimation. At the last hearing on 26.8.2021, the appellant was given one final opportunity to examine the respondent PIO's reply and the appended information for any deficiency. He has however, neither written to the Commission or the PIO about any deficiency, nor he is present at this hearing.

3. This Commission compels to conclude that the appellant is satisfied with respondent PIO's reply vide Letter No. 56/PIO/Z-D Dated 25.8.2021.

1. The RTI application is dated **19.10.2020** vide which the appellant has sought information **regarding Fire NOCs issued to Schools, Buildings and factories**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **24.11.2020** and Second Appeal was filed in the Commission on **28.12.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard on **26.8.2021**.
2. Both parties are present via Video Conference Facility from Ludhiana. At the last hearing on 26.8.2021, Commissioner, Municipal Corporation, Ludhiana, was impleaded in this Appeal Case and directed to upload the fire safety status of all public buildings, schools, and factories, etc. located within his jurisdiction to the Website of the Municipal Corporation, Ludhiana.
3. As per PIO's representative, Navrang Singh, Fire Officer, the information is already available on the website: www.firenoc.lgpunjab.gov.in. Regarding the other point on his RTI application pertaining to the structural safety of public buildings, the appellant is advised to file a separate RTI application to the PIO, o/o PWD, Municipal Corporation, Ludhiana.
4. It is this Commission's view that the information regarding the structural safety of public buildings should be available to the general public via the official website of the Municipal Corporation Ludhiana. Such disclosure would be keeping with Section 4 of the RTI Act, 2005. The Municipal Corporation, Ludhiana is advised to consider the above and upload such information on the Website.
