ORDER

Shri Raju Ambedkar, appellant filed RTI application dated 05.04.2021 and sought some information from the SPIO, O/o Principal, Police DAV Public School, PAP Campus, Jalandhar Cantt. When no information was provided to him by the SPIO then he filed First Appeal before the First Appellate Authority on 07.06.2021. A reply was sent to him vide letter no.240/124 dated 08.06.2021 and the information sought by him was denied. Then the appellant filed Second Appeal before the Punjab State Information Commission on 25.06.2021. The case was registered and allocated to the Bench. Notice of hearing was issued to both the parties for today through **CISCO Webex Meetings Software**.

The appellant is present and Advocate Kapil Sharma is present on behalf of the SPIO. The appellant stated that no information has been provided to him by the SPIO, whereas a period of more than six months has been passed. He further stated that the DEO (SE) Jalandhar has also issued direction to the SPIO to provide the information, but inspite of the directions the SPIO has not provided the information till date.

Advocate Kapil Sharma is present on behalf of the SPIO-cum-Principal, Police DAV Public School, PAP Campus, Jalandhar Cantt. and he stated that the respondent school is a private and unaided school and does not come within the ambit of definition of public authority and the RTI Act, 2005 does not apply to the respondent school.

Before deciding the point and issues we have to go through the definition of 'public authority' as envisaged U/s 2(h) of the RTI Act, 2005, which is as under:-

"public authority" means any authority or body or institution of self-government established or constituted,—

(a) by or under the Constitution;

(b) by any other law made by Parliament;

(c) by any other law made by State Legislature;

(d) by notification issued or order made by the appropriate Government, and includes any—

(i) body owned, controlled or substantially financed;

(*ii*) non-Government Organisation substantially financed, directly or indirectly by funds provided by the appropriate Government;

I have gone through the definition of 'public authority', heard the appellant and the Counsel for the respondent. It is admitted fact that though the school is private, but it is constructed over the land owned by the State of Punjab i.e. Department of Punjab Police. Thus, the present school is a public authority and it comes within the ambit of definition of public authority.

So, I direct the SPIO-cum-Principal, Police DAV Public School, PAP Campus, Jalandhar Cantt. that attested copies of sought for information be sent to the appellant through registered post within 10 days and compliance report be sent to the Commission. In case of non compliance of the order of the Commission strict action will be taken against the SPIO and show cause notice U/s 20(1) of the RTI Act, 2005 will be issued to the SPIO and he will be penalized upto Rs.25,000/-, which will be deducted from his salary.

I have gone through the Order dated 02.09.2021 and a compensation of Rs.2,500/- was awarded in favour of the appellant and the SPIO-cum-SHO, Police Station, Daba, Ludhiana was directed to send the amount of compensation from the funds of public authority by way of demand draft to the appellant through registered post within 10 days along with attested copies of information and to send compliance to the Commission.

But the SPIO is absent today and neither he has sent any compliance report to the Commission.

So, another opportunity is granted to the SPIO to send the amount of compensation of Rs.2,500/- to the appellant from the funds of public authority by way of demand draft through registered post within 10 days along with the attested copies of information and compliance be sent to the Commission. In case of non compliance of the Order of the Commission a Show Cause Notice U/s 20(1) of the RTI Act, 2005 will be issued to the SPIO on the next date of hearing and he will be penalized upto Rs.25,000/-, which will be deducted from his salary.

ORDER

Shri Daljit Singh, appellant filed RTI application dated 04.11.2020 and sought some information from the SPIO, O/o Municipal Corporation, Jalandhar.

Today the case is heard through CISCO Webex Meetings Software.

The appellant is present today, whereas none has appeared on behalf of the respondent SPIO. The appellant stated that neither the information nor the amount of compensation of Rs.3,000/- has been provided to him by the SPIO till date.

I have gone through the Order dated 02.09.2021 and a compensation of Rs.3,000/- was awarded in favour of the appellant and the SPIO was directed to send the amount of compensation from the funds of public authority by way of demand draft to the appellant through registered post within 10 days along with attested copies of information and to send compliance to the Commission.

But the SPIO is absent today and neither he has sent any compliance to the Commission regarding sending the information and the compensation to the appellant. The SPIO was absent on 13.07.2021, 02.09.2021 and today again he is absent without any intimation to the Commission and neither he has provided the information to the appellant nor paid the amount of compensation.

The conduct of the SPIO, O/o Municipal Corporation, Jalandhar amounts to denial of information and defiance of the provisions of the RTI Act, 2005. So, a Show Cause Notice U/s 20(1) of the RTI Act, 2005 is issued to SPIO, O/o Municipal Corporation, Jalandhar that why he has not provided the sought for information to the applicant and so why he may not be penalized up to Rs.25,000/-.

The SPIO is directed to file reply to the Show Cause Notice in writing and send the same to the Commission within 10 days and an opportunity of personal hearing will be

afforded to him on the Show Cause Notice. In case he would not file reply to the Show Cause Notice then it will be assumed that he do not want to say anything in his defence and the Show Cause Notice will be decided without hearing him and he will be penalized accordingly and the amount of penalty will be deducted from his salary.

The SPIO is further directed to send the amount of compensation of Rs.3,000/- to the appellant from the funds of public authority by way of demand draft through registered post within 10 days along with the attested copies of information and compliance be sent to the Commission.
