Presently, as the investigation is pending in the concerned case so the information cannot be provided to the appellant U/s 8(1)(h) of the RTI Act, 2005. Hence, the present appeal case is **disposed of and closed**.

Since the complainant has approached the Commission under the provisions of Section 18 of the RTI Act, 2005, no directions for providing further information can be given by the Commission. An alternative and efficacious remedy of first appeal is available to the complainant under Section 19(1) of the RTI Act, 2005 which has not been availed in the instant case.

So, keeping in view the above, the present complaint case is disposed of and closed with the direction to the First Appellate Authority-cum-DDPO, Patiala that he should call the applicant in his office on any working day within 30 days and hear him sympathetically and resolve the matter involved in the RTI application and pass a speaking order and compliance report be sent back to the Commission. With this observation the present complaint case is **disposed of and closed**.
