 - b) PIO is not supposed to create information that is not a part of record of Public Authority. The PIO is also not required to furnish Information; or to solve problem raised by the applicants; or to furnish replies to hypothetical questions.
 - c) Some information Seekers request the PIO to cull out information from some document(s) and give extracted information to them. A citizen has a right to get material from Public Authority which is held by or under the control of Public authority. The Act, however, does not require the PIO to deduce some conclusion from the material and supply the 'conclusion' so deduced to the applicant. It means that the PIO is required to supply the 'material' in the form as held by the Public Authority, but not to do research on the behalf of citizen to deduce anything from the material and then supply it.
4. After hearing the respondent and going through the documents placed on record, it is found that requisite information in the available format has been provided to the appellant and PIO is neither supposed to create/ deduce some conclusion/ extract information and/or furnish replies to hypothetical questions as mentioned above therefore in the view of above nothing else is left to be supplied to the appellant and hence the instant appeal case is **disposed of and closed**.
