ORDER

1. The RTI application is dated 11.03.2019 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) and second appeal was filed in the Commission on 10.09.2019 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. Notice of hearing was issued to the parties for 19.11.2019 in the Commission
3. The Respondent states that, the available information has been provided to the Appellant.
4. The Appellant states that incomplete information has been provided to her so far.
5. After hearing both the parties and perusing the case file, it is observed that the appellant is not satisfied with the information, hence she is directed to visit the office of the respondent on **25.11.2019 at 11:00AM**, inspect the relevant records, identify the documents copies whereof are required by him; and the respondent shall provided copies thereof, in accordance with the relevant provisions of the RTI Act, 2005.
6. To come up on **16.12.2019 at 11.00 AM** for further proceedings. Copy of the order be sent to the parties.
