ORDER

This order may be read with reference to the previous order dated 22.10.2019 vide which Show Cause Notice was issued to Shri Bhupinder Singh for not appearing and for not supplying the information to the complainant under Section 20 of the RTI Act, 2005. He has failed to file his written submissions and avail of opportunity of personal hearing. A copy of the previous order was sent to Shri Bhupinder Singh, Assistant Collector, Raikot, Sub Divisional Magistrate, Raikot, Sub Divisional Magistrate, Raikot and Deputy Commissioner, Ludhiana for ensuring the presence of the PIO.

- 2. The representative of the complainant states that no information has been provided to the information-seeker till date.
- 3. The respondent-PIO was absent on 22.08.2019, 24.09.2019 & 22.10.2019 and today Shri Jaswinder Tiwana, Tehsildar, Raikot, District Ludhiana-cum-present PIO is absent without any intimation.
- 4. The perusal of the file and the conduct of the respondent-PIO compelled the Commission to issue him a formal show cause notice as to why action under Section 20(1) of the RTI Act 2005 should not be taken against him and he was also provided an opportunity to file his written reply and also make use of opportunity of personal hearing under the principles of natural justice.
- 5. Since the responsibility to ensure the timely transmission of the information to the complainant lies on PIO, Shri Bhupinder Singh, Assistant Collector, Raikot, District Ludhianacum-PIO is hereby held guilty for not providing the information on time as prescribed under Section 7 of the RTI Act, 2005, which is within 30 days of the receipt of the request, and for repeated and willful defiance of the Punjab State Information Commission's order.
- 6. Such kind of failure on the part of the respondent-PIO is totally unacceptable. It is pertinent to mention here that RTI Act has been enacted to ensure participative nature of management between the public & the public authorities and also to know as to what is happening behind the closed doors with regard to the governance affairs of the public authorities and their functioning.

- 6. After giving thoughtful consideration and due perusal of the facts of the case and the material available on record, I have come to the conclusion that PIO has failed to perform his duty as per the mandate of RTI Act which requires the public servant to ensure due transparency and accountability in its functioning. It has also come out that he has not only failed to perform his duty at his own level but also has shown his casual approach in complying with the explicit order of the Commission.
- 7. It has been further established from his conduct that he has failed to provide the information even after getting the formal show cause notice from the Commission. This speaks volumes as to how much respect & regard he has in his mind to the provisions of the RTI Act, which mandates that all public authorities will ensure that RTI Act, 2005 is duly implemented by them, whenever any citizen approaches the public authority to get any public information for which they have right to ask for as per the provisions of RTI Act. In view of the facts mentioned herein, I am of the considered view that Shri Bhupinder Singh, Assistant Collector, Raikot, District Ludhaina-cum-PIO should be penalised for his negligence in discharge of his statutory duty prescribed under RTI Act. His failure to discharge his lawful duty makes me believe that his sheer neglect to perform his duties will be met only after he is duly taken to task as per the provisions of RTI Act i.e Section 20(1) which provides that any delay on the part of the respondent-PIO beyond 30 days is to be penalized @ 250/- per day and to the maximum of Rs. 25,000/-
- 8. Under these circumstances, I am left with no other option but to decide the question of imposition of penalty and quantum thereof upon Sh. Bhupinder Singh, Assistant Collector, Raikot, District Ludhiana-cum-PIO as per the provisions of the RTI Act i.e. Section 20(1) of the RTI Act, 2005. In this case the intervening period is too large, the respondent-PIO failed to comply with the order of the Commission. Accordingly, a penalty of Rs. 10000/-(Rupees Ten thousand only) is imposed on him.
- 9. The amount of penalty i.e. Rs. 10000/- (Rupees Ten Thousand only) should be deducted from his salary in four equal monthly installments and be deposited in the Government treasury under head "0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act. The Sub Divisional Magistrate, Raikot, District Ludhiana/Deputy Commissioner, Ludhiana shall ensure that this amount of penalty is deducted from the salary of the above said defaulting official from the month of November, 2019 onwards and deposited in the Treasury under the relevant head and sent compliance report to the Commission.
- 10. Absence of Shri Jaswinder Tiwana, Tehsildar, Raikot, Distt. Ludhiana, who is the present PIO, is also viewed seriously. Video Conference Facility was introduced for convenience of general public and for government officials. Shri Jaswinder Tiwana was the PIO at the time of filing of application dated 22.04.2019 for seeking information, but he failed to take appropriate action on the application of the complainant at the relevant time. He is contacted on telphone during the hearing, who has told the office of the Commission that he has joined about one month back to this posting. He has also failed in supplying the information since he rejoined the new posting. Viewing the absence of the Shri Jaswinder Tiwana, Tehsildar, Raikot (Ludhiana) seriously, he is, thus, issued a show cause notice to explain in a self-attested

affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay/denial of the information to the RTI applicant.

- 11. In addition to the written reply, the present PIO is also given an opportunity under Section 20(1) proviso thereto, for a personal hearing before the imposition of such penalty on the next date of hearing. He may take note that in case, he does not file his written reply and does not avail himself of the opportunity of personal hearing on the date fixed, it will be presumed that he has nothing to say and the Commission shall proceed to take further proceedings against him ex parte.
- 12. The present respondent-PIO is directed to intimate the complainant after taking appropriate action on the application dated 22.04.2019 with a copy to the Commission before the next date of hearing.

- 2. The complainant sent an e-mail dated 16.11.2019 stating that he sought information from Sub Divisional Officer, Irrigation Department, Doraha, District Ludhiana. In reply to that, they have stated that work was executed by them on behalf of BDPO and all relevant papers have been sent to them for further necessary action, which are on the name of BDPO-cum-Programme Officer (Manrega), confirming this aspect, they have attached a copy of the bill.
- 3. The representative of the respondents states that no observations dated 16.11.2019 have been sent to them by the complainant. A copy of the same has been sent to Shri Gurpreet Singh, GRS on his M.No.97814-00787 through whatsapp for taking appropriate action under provisions of RTI Act, 2005 as early as possible to the complainant with a copy to the Commission.
- 4. To come up on 5.12.2019 at 3.30 P.M. to be heard through Video Conference Facility available in the office of the Deputy Commissioner, Ludhiana.
