- 2. The appellant is absent without intimation. The respondent PIO, represented by Baljeet Singh, Senior Assistant, present through Video Conference Facility at Deputy Commissioner's Office Patiala, has submitted a detailed reply to this Commission's Notice.
- 3. The respondent PIO-cum-Inspector General of Police, India Reserve Battalions states that through this RTI application dated 11.5.2020, the appellant has requested "a certified copy of the Caste Certificate of HC (Head Constable) Saraj Masih No. 7-IRB/94, whose name is at Serial No. 3403 in the Final Seniority List of Head Constables of Armed Battalions after 19.02.2008. or, a certified copy of the Service Book of the above said official." The PIO has argued that the "RTI application was correctly rejected vide Memo No. 9112/A-# dated 9.06.2020, as per the provisions of Section 8(1)(j) of the RTI Act, 2005, because the information demanded by the appellant relates to (a) third party (and is) personal information."

- 4. It is further submitted that a first appeal filed by the appellant on 17.2.2020, "was also rejected by the First Appellate Authority-cum-Special Director General of Police, Armed Battalions, Punjab vide his office No. 9795/CB-SA-2 dated 30.06.2020, on the ground of (the) Punjab Government Notification (No. SO 49/CA. 22/2005/S 24/2016) dated 07.06.2016, in which, Indian Reserve Battalions have been exempted under (Section 24 of the) RTI Act."
- 5. The respondent PIO has also pointed out that "an identical Appeal Case No. 2091 of 2020, filed by the appellant has been dismissed by Sh. Avtar Singh Kaler, Hon'ble Punjab State Information Commissioner vide (his) Order dated 6.10.2020."
- 6. On examining both, the submissions made by the appellant as well as the respondent PIO's reply vide Letter No. 2346/A-3 dated 5.2.2021, this Commission cannot fathom any manner in which the disclosure of the requested information could possibly serve any larger public interest. There is equally no occasion to invoke any exception or proviso to the exemptions claimed, herein, by the respondents in citing Sections 8 and 24 of the RTI Act, 2005.
- 7. Following from above, it is plainly evident that this appeal bears no merit and so, is herewith **Dismissed and Closed**.

Notably, the PIO has cited four other Orders of the Punjab State Information Commission, wherein the concerned commissioners have found in favour of the respondents in similar appeal / complaint cases.
- 6. On examining both, the submissions made by the appellant as well as the respondent PIO's reply vide Letter No. 774/CB-SA-I dated 15.1.2021, this Commission concurs with the respondents and upholds the decisions of the PIO and the FAA.
- 7. Following from above, it is plainly evident that this appeal bears no merit and so, is herewith **Dismissed and Closed**.
