2. The representative of the respondent states that the case is pending in the court pertaining to point no. 4 of the RTI application and next date of hearing is fixed on 7.9.2022 and as such matter being sub judice the information cannot be given to the appellant.

3. The appellant states that the respondent Public Information Officer is misguiding the Commission by not providing the information. He has showed the documents no. 4229 dated 25.8.2021, 5351 dated 17.9.2021, 5751 dated 30.9.2021, and 5341 dated 17.9.2021 (which are also in the case file) issued by the appellate authority and requested the Commission to go through these documents wherein the appellate has passed the contradictory orders and has misguided the Commission.

4. After hearing both the parties and going through the case file, the Commission disagrees with the contention of the representative of the respondents for not supplying the information pertaining to point no. 4 of the RTI application and the respondent Public Information Officer is hereby directed to supply copies of notices issued to the defaulters pertaining to illegal construction done by them within one week of issue of this order with a copy to the Commission. Also copies of the above said letters as shown in para 3 are **being sent to** the Deputy Commissioner, cum Chairman Improvement Trust, Amritsar to look into the matter and may consider to take appropriate action in this regard, if any against the appellate Authority for issuing of contradictory orders by him. No more further action is required in this case. Hence, this case is disposed of and closed. However, the liberty is granted to the appellant to approach the Commission within two weeks if the needful is not done by the respondent Public Officer.

2. The representative of the respondents states that the appellant has sought the voluminous information just to harass the Public Authorities and he has no public interest but has malafide attention to seek the information. He further submits that the appellant was tenant of the shop in school property and was not paying the rent regularly as per terms and conditions of the rent deed or to vacate the property. After lot of persuasion he vacated the

property on 31.10.2019. Also his brother and father who are also tenant of the shops no. 8 and 11 are not paying the rent regularly as per agreement and the school authorities have filed eviction proceedings under section 13 of East Punjab Urban Rent Restrictions Act in the Court of Hon'ble Rent Controller Talwandi Sabo .

Further, the appellant has moved the application to Principal Khalsa Senior Sec. School Boys Talwandi Sabo to become the member of School Management Committee to favour his family members. The application to become the member of the school Management Committee was rejected by the management. Thereafter he has served a legal notice through his advocate to the school management as he was not eligible for the same. He further adds that the appellant is misusing the RTI Act as there is no public interest or bonafide ground involved in it. A copy of submission dated 18.5.2022 along with copy of rent agreement given by the respondent Public Information Officer is taken on the record.

3. The appellant states that he has sought the information as the working of the school management is not transparent and he has public interest in the sought information which he could not prove during the hearing and he also showed his ignorance pertaining to the cases filed against his brother and father in the above said court.

4. Keeping in the view of the above, it is clear that the appellant has no public interest in seeking the information but he has his personal interest in seeking the voluminous information. A specimen copy of rent agreement is **being sent** to the appellant. After due deliberations the respondent cum Public Information Officer is further directed to supply the receipts of auction of 27 acre land given on lease under the intimation to the Commission within 10 days from issue of this order.

With this direction, no action is required in this case. Hence this case is disposed of and closed.
