ORDER

This order may be read with reference to the previous order dated 18.6.2021.

2. The appellant states that he is not satisfied with the information so supplied by the respondents.
3. The respondent-Public Information Officer is absent without intimation. Also the office contacted Sh. Kuldeep Singh, who attended the last hearing, and he assured that he will attend the hearing along with the original record. But neither he nor the representative of the respondents is present. Video Conference Facility/cisco webex facility was introduced for convenience of general public and for government officials. Viewing the absence of the respondent and attitude in dealing with the RTI application of the appellant, Sh. Sanjiv Kumar, Public Information Officer-cum-Sub Registrar Ludhiana East, District Ludhiana, is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing wilful delay/denial of the information to the RTI application and to issue show cause for compensation to the appellant for detriment suffered by him under section 19(8) of the RTI Act, 2005.
