- 4) Attested copy of cash book of panchayat Gura Khurd period 1.1.20013 to 30.10.2018
- 5) Attested copy of last balance in panchayat Gura Khurd 15.12.2018.

3. The appellant has sent a letter which has been diarized in the Commission bearing diary no. 9848 dated 11.8.2020 in which it has been mentioned he has received the information from Block Development and Panchayats Officer concerning mustroll of labour for NAREGA and MANREGA Village Madhopur Cantt. He further mentioned that that there are number of entries which has no signatures of the persons who had received the payment. In this regard the representative of the respondents states that the payment regarding NAREGA and MANREGA is being credited directly in the accounts of the concerned persons so there are no signatures/thumb impression is available on the mustrolls/job cards. Whereas the appellant states that in the absence of signatures/thumb impressions, there may be a misappropriation of payment in this regard for which the appellant has been advised to file an appeal separately to the concerned authorities, as this is not the right forum to deal with.

4. The representative of the respondents further states that the complete information has been supplied to the appellant after his inspection in the presence of his advocate and the appellant agrees with the submissions of the representative of the respondents and states that he has received the complete information.

ORDER

This order may be read with reference to the previous order dated 21.7.2020 vide which the show cause notice was issued to Sh. Gurmeet Singh, Block Development and Panchayats Officer, Sh. Jasbir Singh, ex-Block Development and Panchayats Officer and Sh. Gurminder Singh, Panchayat Secretary for non providing of the information to the appellant along with the directions to supply the information. The case was adjourned to 19.8.2020.

2. Sh. Gurmeet Singh, Block Development and Panchayats Officer states that he has joined on 19.6.2019 at Khadoor Sahib. As far as the information is concerned, the Block Development and Panchayats Officer states that he has brought the information along comprising 154 pages (including 17 pages of NAREGA) the record of which has been taken from Sh. Balraj Singh. He handed over the same to the representative of the appellant. Furthermore, the representative of the respondents states that the information pertaining to year 2017-2018 could not be provided due to non availability/misplacement of the record. In addition, he states that the legal /administrative action has been taken against Sh. Balraj Singh Ex-Panchayat Secretary and recommendation has also been sent to the Police Authorities to lodge an FIR in this regard. Copies of letter No. 1130 dated 19.8.2020 written to the Commission along with letter No. 782 dated 25.6.2020, no. 830 dated 8.7.2020 and letter no. 954 dated 27.7.2020 written to the Deputy Superintendent of Police, Tarn Taran has been sent by the respondents, which is taken on record.

3. The representative of the appellant after going through the information comprising 154 pages so provided by the respondents states that she may be given a week's time to point out deficiency, if any, in the provided information.

4. Sh. Jasbir Singh, Block Development and Panchayats Officer has sent an affidavit with regard to the show cause notice issued to him. After hearing, the Commission is satisfied with the reply sent by him and the show cause notice issued to him is dropped.

5. The appellant has sent an email dated 7.8.2020 vide which it has been requested for the reference received from the Vigilance Department, Punjab. **As such, a copy of the same is being sent with this order.**

5. After hearing both the parties, the respondents are directed to place on record up to date status regarding misplacement of the official record before the next date of hearing. The representative
