The appellant is advised to go through the same and pointed out deficiencies, if any, in the provided information relating to the RTI application and the respondent-Public Information Officer o/o the State Transport Commissioner, Punjab is directed to remove in case any deficiency is pointed out by the appellant before the next date of hearing.
