enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **6.8.2019** and Second Appeal was filed in the Commission on **17.3.2020** under Section 19 of the Right to Information Act, 2005. The case was last heard by Sh. Sanjiv Garg, Hon'ble State Information Commissioner on **21.3.2022**.

2. The appellant is present in person along with his Advocate Shri Balsher Singh. The respondent PIO is absent without intimation. This is despite a Show Cause Notice issued to him vide this Commission's Order of 21.3.2022. In said Show Cause Notice the PIO office of Tehsildar was directed to file a written submission as to why a penalty should not be imposed upon him as per the RTI Act for willful delay/denial in supplying the information sought by the appellant in his RTI application dated 6.6.2019. The respondent PIO has failed to make a written submission and has further also not availed an opportunity offered to him to be heard in person at today's hearing. The Commission deems it fit to impose a penalty of Rs. 10,000/- upon the PIO, O/o Tehsildar. The Commission further awards a compensation of Rs. 10,000/- to the appellant Shri Nirmal Singh.

3. **Order:** Keeping all the facts of the case in mind, this is a fit case to invoke Section 20 of RTI Act and impose a penalty on the respondent PIO Section 20(1), which reads as under:

"Where the Central Information Commission or the State Information Commission, as the case may be, at the time of deciding any complaint or appeal is of the opinion that the Central Public Information Officer or the State Public Information Officer, as the case may be, has, without any reasonable cause, refused to receive an application for information or has not furnished information within the time specified under sub Section (1) of Section 7 or malafidely denied the request for information or knowingly given incorrect, incomplete or misleading information or destroyed information which was the subject of the request or obstructed in any manner in furnishing the information, it shall impose a penalty of 250/- Rupees each day till application is received or information is furnished, so however, the total amount of such penalty shall not exceed Twenty Five Thousand Rupees;

Provided that the Central Public Officer or the State Public Information Officer, as the case may be, shall be given a reasonable opportunity of being heard before any penalty is imposed on him;

Provided further that the burden of proving that he acted reasonably and diligently shall be on the Central Information Officer, as the case may be."

The onus and responsibility lie on the PIO to ensure the transmission of the complete information to the appellant. The **concerned PIO office of Tehsildar Khadoor Sahib, Tarn Taran**, is hereby held guilty for not providing the information on time as prescribed under Section 7, which is within 30 days of the receipt of the request and for repeated and willful defiance of the Punjab State Information Commission's orders.

A penalty of Rupees Ten Thousand (Rs. 10,000/-) is hereby imposed upon the **concerned PIO office of Tehsildar Khadoor Sahib, Tarn Taran**, which be deducted from his salary and deposited in the Punjab Government Treasury under head "0070-Other Administrative Services-60-other Services-800-Other Receipts-86-Fees Under the Right to Information Act." The **concerned PIO office of Tehsildar Khadoor Sahib, Tarn Taran**, is directed to duly inform the Commission of the compliance of the orders by producing a copy of the challan. Copies of this order be sent to the parties through registered post.

This is to be paid vide a crossed cheque / demand draft, by the Public Authority, in this instance, the office of **Tehsildar Khadoor Sahib, Tarn Taran**, within 15 days of receiving this order. Proof of payment is to be submitted to this Commission.

5. The respondent PIO office of Tehsildar Khadoor Sahib, Tarn Taran, is further directed to supply the requested information to the appellant. All the above must be done within 30 days of receipt of this Order. This Appeal Case is accordingly **Disposed of**.
