- 4. However, the respondent-Public Information Officer-cum-Block Development and Panchayats Officer Sh. Varinder Kumar states that he has brought the bank draft amounting to Rs.15,000/- and the cheque amounting to Rs.2560/- has already been sent to the appellant.
