2. Both parties are present through Video Conference Facility. The respondent PIO is represented by Lalpreet Singh, Joint Secretary, Technical-3 Branch, PSPCL Patiala and Kulraj Singh, XEN, PSPCL Lehradgaga. They stated that a reply along with requested information have already been supplied to the appellant. The appellant however, contended that the information is incomplete.

3. The respondents are directed to send copies of the reply/letter/information sent to the appellant, to this Commission. The appellant is advised to list the deficiencies in a letter to the respondent PIO with a copy to this Commission.
