1. ### Complaint Case No. 174 of 2020 (Video Conference Proceedings)

1. The complainant, **Harvinder Singh**, filed this RTI application dated **20.11.2018** and sought Information **regarding documents submitted by Paramjeet Singh, at the time of promotion from the post of peon to the post of clerk**, from the PIO o/o **Secretary, PSPCL, Sangrur**. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **12.2.2020**. The case was last heard on **26.8.2020**.

2. Both parties are absent. While the complainant is absent without any intimation, the respondent PIO has informed the Commission that he is unable to attend this hearing due to a shutdown in his office because of the ongoing Covid-19 situation. However, as directed by this Commission at the last hearing on 26.8.2020, the respondent has sent a copy of the reply sent to the complainant vide memo no. 618 dated 24.1.2019, wherein he/she has contended that the requested information pertains to a third party who has refused to allow its disclosure to the complainant. This Commission concurs with the respondent PIO's stand that the information is exempt from disclosure as the 3<sup>rd</sup> party information.

3. There is no further cause for action and this complaint case is herewith **CLOSED**.
