2. The representative of the respondents filed the written response regarding the sought information vide which the information has been denied in accordance with the decisions of the Hon'ble Supreme Court of India in Civil Appeal No. 10044 of 2010 on 13.11.2019 and SLP No. 27734 of 2021 –Girish Ram Chander Deshpandey vs Central Information Commission on 3.10.2012, which is taken on record.
