3. The appellant states that he has received the complete information and is satisfied with the same except a copy of the measurement book i.e. Point No.9 of the RTI Application. However, the Respondent/Public Information Officer-Sh. Vikramjeet Singh states that a copy of the measurement book has already been supplied to the appellant and he also assured that a certified copy of the same will again be sent to the appellant with a copy to the Commission. With regard to the penalty, he states that the penalty amounting to Rs.10,000/- has already been deducted from his salary and he will submit a copy of proof in this regard. In addition, he also requested that the case may be closed and assured that a copy of the measurement book along with the receipt of the recovery of penalty amounting to Rs.10,000/- will be submitted to the Commission.

3. As per the assurance given by the Respondent-Public Information Officer, he is directed to place on record a copy of the measurement book as has been sought by the appellant in Point No.9 of the RTI application duly certified along with receipt of the recovery made from his salary amounting to Rs.10,000/- penalty within 2 weeks. On receipt of a certified copy of the measurement book, the same will be transmitted to the appellant through Registered Post. Also, a copy of this
