1. The RTI application is dated **25.11.2020** vide which the appellant has sought information **regarding building plans of residential and commercial schemes of Narotam Nagar and Narotam Nagar Extension in Khanna**, as enumerated in his RTI application. First Appeal was filed with the First Appellate Authority (FAA) on **4.1.2021** and Second Appeal was filed in the Commission on **31.5.2021** under Section 19 of the Right to Information Act, 2005. The case was last heard on **10.12.2021**.

2. The respondent PIO is absent without intimation. As per this Commission's Order of 10.12.2021, the respondent PIO has submitted copies of the relevant register, which is maintained in his office with entries regarding sanction plans etc vide Letter No. 10 Dated 24.12.2021, along with some 105 pages. In an earlier reply to this Commission's Notice of Hearing, vide Letter No. 6 Dated 26.10.2021, the respondent PIO, represented by APIO Avtar Singh submitted that the information pertaining to point no. 1, was offered to the appellant by way of copies of the register on which the record of sanctioned plans etc. is being maintained. This was however, refused by the appellant. With regard to point No. 2, the respondent states that the information / record, in the form requested by the appellant, is not maintained in the office of the Improvement Trust Khanna. Notably, the Appellant, who is present, insists that it was the "duty" of the respondent to maintain the record in the format sought in his RTI application.

3. In view of the contrary contentions, the Commission directs the respondent PIO, office of Improvement Trust, Khanna, to submit a duly **notarized affidavit** by way of a pointwise reply to this RTI application. The original affidavit is to be sent to the appellant by registered post and a copy of the same is to be submitted to the Commission within Two weeks of receipt of this Order.

The respondent PIO-cum-XEN, B&R, Zone D, must be present in person or depute somebody with adequate knowledge of record to assist the appellant in said inspection. Documents cited by the appellant during said inspection are to be copied, certified, and supplied to the appellant free of cost. Failure to comply this Commission's direction, shall invite penalty as per the RTI Act 2005.
