**ORDER** 

The case was reserved on 17 August 2021 on the submissions made by the Block Development and Panchayats Officer that the remaining information in this case pertaining to point number 3 and 4 of the RTI application is in the custody of Mrs Parmjit Kaur, Block Development and Panchayats Officer, who has not handed over the record. She was already impleaded as necessary party in this case on 19.1.2021. During the hearing on 17.8.2021, Mrs Parmjit Kaur, Block Development and Panchayats Officer, Patran submitted that the information pertaining to point number 3 and 4 of the RTI application cannot be supplied as the same relates to 3<sup>rd</sup> party.

2. After hearing, Mrs Paramjit Kaur, Block Development and Panchayats Officer was directed to submit the details within a week's time that which type of personal information mentioned in letter number 2593-97 dated 6<sup>th</sup> December 2018 and letter number 185 dated 10<sup>th</sup> February 2020 as has been sought by the appellant. But no reply has been received from her so far. The office also reminded her on telephone repeatedly to provide the same to take the matter to its logical end but even though no reply has been sent by her.
