Hence, I award a compensation of Rs. 2,000/- (Two Thousand Only) to the appellant. The compensation amount must be paid by the respondent PIO concerned through cheque or demand draft in favor of **Jasbir Singh** from the account of Public Authority and not from the individual's account.

6. Respondent PIO is directed to produce a copy of the cheque or demand draft on the next date of hearing.
