Harjeet Singh pleaded that only information pertaining to **point no. 1** of the RTI application is available in his office (PWD B&R, Patiala), which is already available on the official website i.e. eproc.punjabmail.gov.in and remaining information related to the office of PWD B&R, Nabha.
