This order may be read with reference to the previous order dated 22.03.2021 vide which neither the appellant nor the respondent was present.

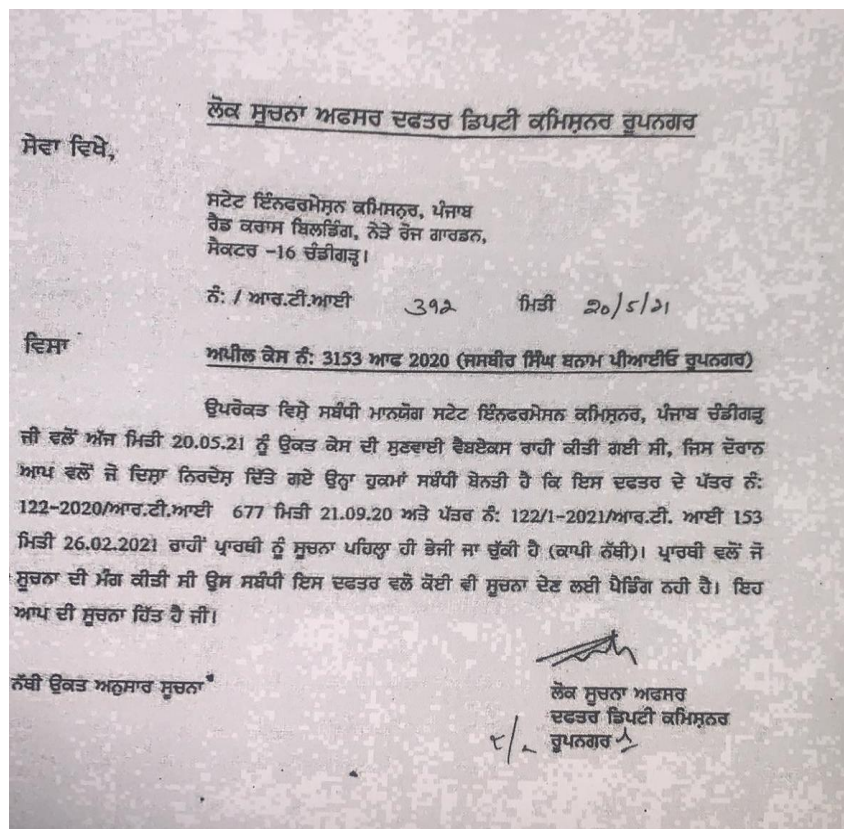
2. Today again the appellant is not present. He sent an email.
