The SPIO was absent on 08.12.2020, 27.04.2021 and today again he is absent and neither he has sent any mail to the Commission regarding the reply to the complaint filed by the complainant/applicant.

So, a last opportunity is granted to the SPIO, O/o Incharge, Police Post, Ram Tirath, Amritsar that he should file reply to the complaint filed by the complainant-applicant and send the same to the complainant-applicant and also to the Commission within 15 days. In case of non compliance of the order of the Commission a show cause notice will be issued to the SPIO on the next date of hearing.
