The complainant-applicant is present today, but none has appeared on behalf of the SPIO. The complainant-applicant stated that no information has been provided to her by the SPIO.

The Commission has received an e-mail sent by the SPIO, which is a copy of letter no. 17514-15 dated 26.04.2021 along with copies of information.

I have gone through the above said letter vide which the sought for information has been sent to the complainant/applicant and a copy of the same has also been sent to the Commission.

I have gone through the RTI application dated 18.03.2020 filed by the complainant/applicant and she sought information regarding case number 0067 dated 28.03.2019.
