ORDER

1. The RTI application is dated 29.11.2021 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 21.01.2022 and the second appeal was filed in the Commission on 07.04.2022 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 20.06.2022. Accordingly, the case has been heard today. Shri Sanjeev Kumar, appellant comes present to attend the hearing in person before the Bench.
3. Ms. Sheenu, Clerk and Shri Gurpreet Singh, Junior Engineer O/o Estate Officer, Patiala Development Authority, Patiala come present in person before the Bench to attend the hearing on behalf of the PIO. Ms. Sheenu states that she has brought along the information and produces before the Bench copy of letter dated 17.06.2022 along with copies of plans. On the asking of the Bench, she hands over a copy of the same to the appellant. The Bench advises the appellant to sit in the adjacent court room and peruse the information supplied by the PIO.

4. The appellant, after perusal of the information, states that the plans of only three/ four SCOs have been supplied whereas no details regarding the encroachments on Govt. land have been provided. The representative of PIO states that only control sheet can be provided to the appellant and plans of the individual cannot be supplied, being personal document.

5. Post deliberations, the Bench directs the PIO to call the appellant to office and allow him access to the relevant official records. The appellant be provided information as may be identified by him. Since the information sought is in the public interest, the information relating to outside structures of the SCOs as per RTI application, be provided to the appellant before the next hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 28.07.2022 at 11.30 AM in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
