## **ORDER**

This order may be read with reference to the previous order dated 30.6.2021 vide which the order in this case was reserved to be pronounced.

2. The appellant has sought the following information:-

respondent-Public Information Officer vide letter No. 126720/2021 dated 5.1.2021, issued a letter and the relevant portion of the same is reproduced below:-

ਆਪ ਵਲੋਂ ਮੰਗੀ ਗਈ ਸੂਚਨਾ ਤੀਜੀ ਧਿਰ ਨਾਲ ਸਬੰਧ ਰੱਖਦੀ ਹੈ। ਇਸ ਤੋਂ ਪਹਿਲਾਂ ਕਿ ਆਪ ਨੂੰ ਸੂਚਨਾਂ ਅਧਿਕਾਰ ਐਕਟ, 2005 ਅਧੀਨ ਮੰਗੀ ਸੂਚਨਾ ਭੇਜੀ ਜਾਵੇ, ਇਹ ਸਪੱਸ਼ਟ ਕੀਤਾ ਜਾਵੇ ਕਿ ਭਾਰਤ ਸਰਕਾਰ ਵੱਲੋਂ ਜਾਰੀ ਗਾਈਡਲਾਈਨਜ਼ ਵਿੱਚ ਦਰਜ਼ ਉਪਬੰਧਾ ਦੇ ਸਨਮੁੱਖ ਸੂਚਨਾ ਪ੍ਰਾਪਤ ਕਰਨ ਲਈ ਆਪ ਦਾ ਵਧੇਰੇ ਲੋਕ ਹਿੱਤ (larger public interest) ਕੀ ਹੈ।

- 4. The appellant filed the first appeal before the First Appellate Authority on 27.1.2021 and on the basis of the directions of the First Appellate Authority, information comprising of 44 pages was supplied to the appellant vide letter No. 148742/2021 dated 24.2.2021.
- 5. Feeling aggrieved, the appellant filed the 2<sup>nd</sup> appeal before the Commission on 5.4.2021 and the case was listed for hearing on 23.6.2021. During the hearing the representative of the respondents stated that the information comprising 44 pages have already been sent to the appellant through registered post as well as through email. But due to absence of the appellant on the said date, the case was adjourned to 30.6.2021.
- 6. During the hearing on 30.6.2021, the appellant stated that partial information comprising 44 pages has been supplied by the respondents and requested to penalize the respondent-Public Information Officer due to delay and partial information. However, the representative of the respondents stated that the information as available on record has already been supplied and nothing more is available on record which could be supplied to the appellant in this case. Thereafter the appellant requested that the respondent-Public Information Officer may be directed to file an affidavit in this regard.
- 7. During the hearing the representative of the respondents reiterated that information comprising of 44 pages stands provided to the appellant and no more information is available in record which could be provided to him. It has also been noted that appellant has not been able to point out any deficiency in the provided information and is stressing upon to issue directions to the respondents for filing affidavit on the point that no more information is available in their record.
