The appellant, Shri Jagshir Singh stated that complete information has not been provided to him by the respondent and neither the amount of compensation of Rs.10,000/- has been paid.

Shri Nirmaljit Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab Singh stated that he has deposited the amount of penalty of Rs.12,500/- in the Govt. Treasury vide E-Challan Receipt No.1338181 dated 14.07.2021. He further stated that the demand draft of compensation of Rs.10,000/- in favout of Shri Jagshir Singh is also ready to be provided to the appellant. He has submitted the copy of E-challan and a photocopy of Demand Draft No.000987 dated 16.07.2021, which is taken in the file of the Commission.

Shri Nirmaljit Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab Singh is directed to contact the appellant, Shri Jagshir and call him in his office for the inspection of the relevant records and to provide the attested copies of remaining information and also provide the demand draft of Rs.10,000/- as compensation to the appellant and compliance be sent to the Commission accordingly.

I have gone through the Order dated 27.05.2021 and non-bailable warrants of Shri Parminder Singh, SPIO-cum-BDPO, Ghal Khurd and Shri Nirmaljit Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab Singh were issued through the SSP, Ferozepur for their presence before the Commission on 20.07.2021.

In compliance to the non-bailable warrants, the APIO-SP (Investigation), Ferozepur has sent a mail to the Commission on 14.07.2021, diarized vide no.15510, which is a copy of letter no.434/RTI-1 dated 12.07.2021 along with a report dated 09.07.2021 of Police Station, Ghal Khurd.

I have gone through letter no.434/RTI-1 dated 12.07.2021 and it is submitted by the SP(Investigation), Ferozepur that H.C. Navjot Singh has submitted the compliance report regarding the non-bailable warrants of Shri Parminder Singh, SPIO-cum-BDPO, Ghal Khurd and Shri Nirmaljit Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab that he has apprised both of them regarding the next date of hearing and they have signed on the report.

I have perused the case file and vide Order dated 25.11.2020 a penalty of Rs.12,500/- each was imposed upon Shri Parminder Singh, SPIO-cum-BDPO, Ghal Khurd and Shri Nirmaljit Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab Singh and a direction was issued to deduct the amount of penalty from the salaries of the concerned persons and to deposit in the Govt. Treasury.

Shri Nirmaljit Singh, PIO-cum-Panchayat Secretary, Gram Panchayat, Ratta Khera Punjab Singh has deposited the amount of penalty of Rs.12,500/- in the Govt. Treasury vide E-challan No.1338181 dated 14.07.2021. But no compliance report regarding the deposit of penalty by Shri Parminder Singh, SPIO-cum-BDPO, Ghal Khurd has been received in the office of the Commission till date.

So, the District Development and Panchayat Officer, Ferozepur is directed that it would be his responsibility to deduct the amount of penalty of Rs.12,500/- from the salary of Shri Parminder Singh, SPIO-cum-BDPO, Ghal Khurd and be deposited in the Government Treasury in the following heads and compliance report be sent back to the Commission before the next date of hearing :-
