ORDER:

The appellant, through an RTI application dated 23.05.2021 has sought a copy of the action taken, alongwith the enquiry report, relating to a dope test conducted on the Punjab Police employees, Taran Taran. As per the RTI application, in the test conducted in the year, the test report was negative, but when conducted in Civil Hospital Amritsar, it was positive, after which an enquiry was marked.

The appellant was not provided with the information, after which the appellant filed a first appeal before the First Appellate Authority on 24.06.2021, which did not decide on the appeal.

The case came up for hearing on 27.06.2022 through video conferencing at DAC Ludhiana/Tarn Taran. The appellant claims that the PIO has not supplied the information.

The respondent present pleaded that since the record was not traceable, the information could not be provided, and they are tracing the record and assured to provide the information within a week.

The PIO was directed to provide the information to the appellant within a week and send a compliance report to the Commission. It may also be mentioned that if the record is found untraceable, the commission will initiate an enquiry to fix the responsibility as well as take steps to create a duplicate record of the untraceable enquiry report.

The appellant inspected the record on 01.07.2022 and, through a letter dated 28.06.2022, accepted that he had inspected the record and got the necessary information, which is also being sent to Commission for kind perusal.

Having gone through the RTI application and reply of the PIO, the Commission observes that the RTI application has been sufficiently attended to and information has been supplied to the appellant.
