ORDER:

This case was last heard on 18.08.2020 vide which the Respondent/ PIO concerned was directed to supply the **point wise reply** to the Appellant, before the next date of hearing.

In today's hearing, the representative of the Respondent/ PIO, Sh. Baldev Singh states that the information has been sent to the Appellant vide letter number 64546 / 2020 dated 17.08.2020 and a copy of the same has been sent to the Commission as well, which is taken on record. He further mentions that the information has also been sent to the Appellant vide letter number 506 dated 14.10.2019 and also through letter number 234 dated 10.07.2020.

On this, the Appellant, Sh. Ashok Kumar states that they are giving incomplete information like they had not given any information of the year 2000-2001 or the year 2003 - 2004, moreover, as discussed on the last hearing, the Respondent/ PIO was directed to mention in writing that after the year 2004 no grant has been given to the said institute, but they did not provide such letter or in any written form till date.

After discussing with both the parties and going through the case file, it has been observed that the letter number 64546 dated 17.08.2020 which has been sent by the Respondent / PIO is not appropriate and contains vague replies.

In the reply, the Respondent/ PIO has not mentioned that after the year 2004 no grant has been given to the said institute, also they had written that the point number 02 of the RTI Application is in question form, which is not true. **This is unacceptable.**

Commission takes a serious view of the casual approach of the Respondent / PIO, as Sh. Baldev Singh who is present today is giving vague replies and he is misleading the Court as well. As on the previous hearing dated 18.08.2020, it was clearly discussed



with the representative of the Respondent/ PIO, Sh. Baldev Singh and still they are submitting the letter, which is not relevant.

In view of the above, a show cause notice under Section 20 (1) of the RTI Act is issued to the 'concerned' PIO O/o The Director Technical Education and Industrial Training Punjab (Technical Education Wing), Plot Number 01, Sector 36-A, Chandigarh as to why penalty be not imposed upon him for willful delay in supplying the information to the RTI Appellant and as to why the compensation be not awarded to the information-seeker under the provisions of the RTI Act, 2005.

In addition, the PIO is also hereby given an opportunity under Section 20(1) provision thereto, for a personal hearing with the sought for information, before the imposition of such penalty on the next date of hearing.

The Respondent/ PIO (i.e. O/o **The Director Technical Education and Industrial Training Punjab (Technical Education Wing), Plot Number 01, Sector 36-A, Chandigarh**) is directed to supply the requisite information to the Appellant, by registered post or through email along with a copy to the Commission, within a week, failing which the penalty will be imposed in the concerned PIO on the next date of hearing.

The PIO, Sh. Jaspal Singh Kang is directed to appear in person on the next date of hearing which is going to be heard through Cisco Webex Meetings Software. The Respondent/PIO concerned is also directed to submit copy of postal receipt or submits a copy of an email, through which information would be sent to the Appellant, by the next date of hearing.

The Appellant is advised to go through the requisite information, once he receives the same from the Respondent/PIO and point out deficiencies in written, if any, to the Respondent/PIO through registered post or through email, with a copy to the Commission, failing which the case will be decided on merits.

This case is adjourned to '03.11.2020 at 11:00 A.M.' and both the parties are directed to be present on the next date of hearing i.e. 03.11.2020, which is going to be heard through Video Conference Software/ Application Cisco Webex Meetings.

In addition, the PIO's are also hereby given an opportunity under Section 20(1) provision thereto, for a personal hearing with the sought for information, before the imposition of such penalty on the next date of hearing.



Both the PIO's' i.e. PIO O/o The General Manager, Pepsu Road Transport Corporation, Bathinda (Punjab) and PIO O/o The Commissioner, Municipal Corporation, Bathinda are directed to appear in person for clarifying the facts of this case, on the next date of hearing which is going to be heard through Cisco Webex Meetings Software.

The concerned PIO's are advised to supply the requisite information to the Complainant by hand or through registered before the next date of hearing, failing which further action would be taken against the PIO and if the information is not available with them then the PIO is advised to file a proper reply in the form of an affidavit explaining with the reason, why the information could not be supplied to the Complainant till date. The PIO's are also advised to send the copy of the reply to the Commission along with a copy of the registered postal receipt if it has been sent to the Complainant by post by the next date of hearing. **A copy of this order be sent to the concerned through registered post.**

The Complainant is advised to go through the supplied information, once he receives the same from the Respondent/PIO and point out deficiencies in written, if any, to the Respondent/PIO through registered post or through email, with a copy to the Commission, failing which the case will be decided on merits.

This case is adjourned to '03.11.2020 at 11:00 A.M.' and all the parties are directed to be present on the next date of hearing i.e. 03.11.2020, which is going to be heard through Software/ Application Cisco Webex Meetings (Meeting Joining number is '918782948').
