The Respondent reiterates his earlier version that the sought for information by the Appellant is third party information and as such, the same cannot be supplied to the Appellant under section 8 (1) (J) of the RTI Act, 2005 and same has been conveyed to the Appellant vide letter no. 13/55-19RB(3)/202082447, dated, S.A.S. Nagar: 06.03.2020.

In view of the above, the Bench agrees with the contention of the PIO that the information sought is 3rd party information. The PIO has rightly denied this information to the Appellant. Accordingly, the Appeal case is **disposed of and closed**. Copies of the order be sent to the parties.
