ORDER

provisions of the RTI Act, after giving due opportunity to the parties concerned, examining the evidences, documents placed on record/submitted by the parties concerned and subsequently pass an order. A copy of this order along with RTI request be sent to the First Appellate Authority i.e. Deputy State Transport Commissioner, Punjab, SCO-177-178, Sector 17-C, Chandigarh through registered post.

If the Appellant is not satisfied with the decision of the First Appellate authority, he is free to approach the Commission within one month.

Copies of the orders be sent to the parties through registered post."

3. Keeping in view the above, the liberty was granted to the appellant to approach the Commission within one month but since then no submissions have been received from the appellant. Therefore, the Commission is of the view that no further action is required to be taken in this case. Hence, the case is disposed of and closed.
