In other words the information-seeker can ask for the information but not for the reasons or justification for the material available on the record. No public authority is supposed to create or manufacture information for the benefit of the information seeker according to the provisions of the RTI Act and various judgments of different courts. Accordingly, the present case is disposed of and closed. Copies of the order be sent to the parties.

Viewing the absence of the respondent seriously, Shri Vikramjit Singh Panthe, Sub Divisional Magistrate, Malerkotla-cum-PIO is, thus, issued a show cause notice to explain in a self-attested affidavit as to why a penalty @ Rs.250/- per day of delay subject to a maximum of Rs.25000/- till the complete information is furnished, be not imposed under Section 20(1) of RTI Act, 2005 on him for causing willful delay/denial of the information to the RTI applicant and why the compensation be not awarded to the information-seeker under Section 19(8)(b) of the Act for the detriment suffered by him.

5.
