



So, as per the definition of information as envisaged in Section 2(f) of the RTI Act, 2005, the attested copies of these agreements had already been provided to the appellant that Er. Karamjit Singh is being paid as per the terms of the agreement mentioned above. So, the information sought by the appellant regarding para no. 8 had already been provided and so far as the information regarding para no. 10 of the RTI application is concerned it is regarding uploading of the information upon the Website of the department. The reply was submitted by the PIO that the information regarding para no. 10 is available on the Website of the department https://pwdpunjab.gov.in and is open for public domain and any person who require the information can download from the Website of the department. At this stage, the appellant raised the contention that the entire information is not uploaded on the Website of the department. The PIO is directed that in case any information regarding para no. 10 is not uploaded on the Website that be uploaded on the Website of the department within 30 days and with this observation the present appeal case is disposed of and closed.
