**ORDER**

1. The RTI application is dated 29.11.2020 vide which the appellant has sought information as enumerated in his RTI application. First appeal was filed with the First Appellate Authority (hereinafter FAA) on 14.12.2020 and the second appeal was filed in the Commission on 09.09.2021 under Section 19 of the Right to Information Act, 2005 (hereinafter RTI Act).
2. The notice of hearing was issued to the parties for 20.12.2021 in Commission's office at Chandigarh. Shri Karamjeet Singh, appellant along with Smt. Kamaljit Kaur, President, Sarb Sanjhi Shaheed Bhagat Singh Dharamshala, Lehragaga, comes present to attend the hearing in person before the Bench. He states that two Bath rooms were got constructed by Panchayat Raj Department in Shaheed Bhagat Singh Dharamshala, Lehragaga and he has sought copies of the bills raised by the contractor which have not been provided to the appellant.
3. Shri Ajay Verma, Senior Assistant O/o XEN Panchayati Raj, Sangrur comes present to attend the hearing in person before the Bench and states that the work of construction of bath rooms was got done through the contractor who had purchased material at his level and he was

made payment at CSR rates as per agreement. He further states that the information has also been sent to the appellant in this regard vide letter dated 06.10.2020 and the appellant had also expressed his satisfaction on receipt of information during the hearing in First Appeal filed by him and accordingly, his first appeal was disposed off by the First Appellate Authority on 21.02.2021.

4. On the asking of the Bench, the appellant states that he had received the information but he was not satisfied with the information as the same is partial information. He further states that the work of the construction of bath rooms in the Dharamshala is still incomplete and the completion certificate has also not been provided by the PIO. Smt. Kamaljit Kaur, President of Dharamshala Committee states that they were also assured by the departmental authorities regarding completion of the work but bath rooms constructed are still in unuseable condition.

5. Post deliberations with the appellant and the representative of PIO, the Bench observes that the contention raised by the PIO is not tenable and directs the PIO to supply complete information to the appellant as sought by him, before the next hearing.

6. With the aforesaid directions, the matter is adjourned. **To come up for hearing on 02.03.2022 at 11.30 AM before the Bench in Commission's office at Chandigarh.** Copies of the order be sent to the concerned parties.
