#### ORDER:

(To be read in continuity with earlier orders on **7.11.19** and **8.1.2020**)

1. The complainant, **Kulwant Kaur**, filed this RTI application dated **15.6.19** and sought information <u>regarding the inquiry report on her application bearing Diary No. A-82 (CC-4)</u> <u>dated 19.2.2018 CR No. 106</u>, from the PIO o/o Director, Bureau of Investigation, Pb., Chandigarh. When no information was received, the Complainant filed a complaint under Section 18 of the RTI Act, 2005 to the Commission on **2.9.19**. The case was last heard on **8.1.2020**.

2. Both parties are present. The respondent PIO represented by Joginder Kumar, clerk, stated that as directed by the Commission at the last hearing on 8.1.20, he reexamined the record with respect to the deficiencies pointed out by the complainant. However, he found no information other than that already given to the appellant.

3. The complainant was however, not satisfied and continued to insist that the specific inquiry/investigation report requested by her, has not been furnished by the respondent.

4. At the last hearing on 8.1.2020, the respondent PIO-cum-SSP Fazilka was directed that in the event that the requested information is not available in his official records, he must submit a duly notarized affidavit stating this.

5. The respondent PIO-cum-SSP Fazilka has submitted an affidavit at this hearing, which submits as under:

"1. It is submitted that information required by applicant Smt Kulwant Kaur has been sent through registered post vide this office memo No. 1064-66-RTI-1 dt. 05/11/2019.

2. It is submitted that in compliance of order no. 44134Dt. 25/11/2019 passed by Hon'ble Information Commission, Information has been sent to applicant Smt. Kulwant Kaur through registered post vide this office memo no. 1406-08-RTI-1 dt.20.12.2019."

3. It is submitted that no any information pending in this office till now."
