ORDER

This order may be read with reference to the previous order dated 18.3.2021 vide which the case was adjourned for 19.4.2021 but due to administrative reasons the case was further adjourned for today i.e. 20.5.2021.

2. The appellant has sought the certified copy of the action taken on “ਰਾਸ਼ਟਰਪਤੀ ਭਵਨ ਦੀ ਪਟੀਸ਼ਨ Sl.No. P2/D/1105170243 dated 11.5.2013 and Sl.No. P2/G/1807190205 dated 18.7.2019”
3. The appellant states that the respondents be directed to supply the complete information in this case. However, the Public Information Officer states that he is the Public Information Officer of the office of the Director, Employment Generation but the information in this case was to be supplied by the Establishment Branch. He further states that as per the report of the Establishment Branch an enquiry is going on so the matter regarding the sought information is under consideration. He has also sent a copy of the reply in this regard, which is taken on record. In addition, the respondent-Public Information Officer tenders unconditional apology regarding the delay occurred in this case and requested to withdraw the show cause notice issued to him. Reply of the show cause notice given by the respondent-Public Information Officer has already available, which is taken on record.
