2. The appellant states that the respondent-Public Information Officer may be directed to supply the complete information in this case. However, the representative of the respondents states that the information pertaining to Point No. 3 & 4 of the RTI application cannot be supplied due to security reasons the same is exempted under Section 8(1)(j) & 8(1)(g) of the RTI Act, 2005 as the appellant has sought the information related to the security personnel posted with the Deputy Commissioner, Patiala. The representative of the respondents further states that the information pertaining to Point No. 1 & 2 of the RTI Act, 2005 cannot be supplied after its creation.

3.
