Since Ms. Anu Bala, Appellant was absent on three consecutive hearings, as such, she was advised to go through the information and point out deficiencies. She was also given opportunity to appear in person or through representative on the next date, and that in case she does not come present, it would be presumed that she has received the information and is satisfied with the same.

Today, Sh.Saraj Singh comes present on behalf of the Appellant Ms. Anu Bala. He produces authority letter and states that the information regarding Point No.3 is yet to be supplied. An e-mail has also been received today from the appellant that information on point No.3 is not as per her requirement.

On the asking of the Court, Smt. Renu Sharma, Sr. Asstt. who is present today on behalf the PIO/Respondent, hands over a copy of letter dated 05.09.2011 to the representative of Appellant as also submits a copy to the Court which is taken on record. The representative of Appellant expresses satisfaction on the information supplied regarding Point No.3. He also gives in writing to this effect.

In view of the above, **the Appeal is disposed of and the case is closed.**

## **Appeal Case No. 1710 of 2018**

**Present:** The Appellant Sh.Jasbir Singh is present.  
None is present on behalf of PIO/Respondent.

**ORDER:**

The case was last heard on 28.11.2016. The Appellant Sh.Jasbir Singh was absent on the last date of hearing. None was present on behalf of the PIO/Respondent.

On the last date, on examining the record, it was found that the PIO/Respondent was absent on two hearings and as such, PIO/Respondent, O/o SDM-cum-Licensing & Registering Authority, Dharamkot, District Moga was issued show cause notice under Section 20(1) of RTI Act as to why penalty be not imposed upon him for willful delay in supplying the information to the Appellant and as to why the compensation be not awarded to the information seeker under the provisions of RTI Act. PIO was also given an opportunity under Section 20(1) provisions thereto, for a personal hearing with the sought for information before the imposition of such penalty on next date of hearing.

It is observed that PIO/Respondent has failed to come present before the Commission for the third consecutive hearing and has also not supplied the information to the Appellant.

**In view of the above, a penalty of Rs.2500/- (Rupees two thousand five hundred only) is imposed on the concerned PIO/Respondent, O/o Sub Divisional Magistrate-cum-Licensing & Registering Authority, Dharamkot, District Moga. The amount of penalty i.e. Rs.2500/- should be deducted from the salary of the PIO and be deposited in the Govt. Treasury under the head "0070-Other Administrative Services-60-Other Services-800-Other Receipts-86-Fees under the Right to Information Act".**

PIO/Respondent is also directed to submit the proof of having deposited the penalty on the next date of hearing. PIO/Respondent is further directed to supply the complete information before the next date of hearing. Copy of this order be sent to him through registered post for his ready reference.

The Appellant is also advised to go through the information after the same is received by him and also point out deficiencies, if any, in the information supplied to him.

Both the parties to come present on the next date of hearing which is fixed for **18.03.2019 at 11.00 AM.**
