ਹੁਣ ਅੱਡ-2 ਥਾਣਿਆਂ ਤੇ ਪਤਾ ਕਰਨ ਤੇ ਚੌਕੀ ਜਗਤਪੁਰੀ ਥਾਣਾ ਹੈਬੋਵਾਲ ਲੁਧਿਆਣਾ ਤੇ ਦਰਖਾਸਤ ਸੀ.ਆਰ. ਨੰ: 1203963 ਮਿਤੀ 04.10.2017 ਰਿਕਾਰਡ ਮੰਗਵਾਇਆ ਗਿਆ ਹੈ। ਜੋ ਤਰੀਕ ਪੇਸ਼ ਪਰ ਪੇਸ਼ ਕੀਤਾ ਜਾਵੇਗਾ ਜੀ।

He further states that complainant was failed to give correct number of his complaint while seeking information in his application under RTI regime. They have located the correct number from UID. After locating the same, they have brought the relevant information after collecting it from different police stations, to be supplied to the appellant, who is absent and nothing has been kept pending, which can be supplied to the appellant as per his RTI application.

5. The representative of the respondents is directed to send the information to the

appellant through registered post office. The appellant is advised to go through the same and revert back to the authorities, in case of deficiencies, within a week's time. On receipt of the deficiencies from the appellant, the respondents are directed to remove the same before the next date of hearing, which is fixed for 27.02.2019.

## Appeal Case No. 2155 of 2017

### ORDER

This order may be read with reference to the previous order dated 13.09.2018 vide which a penalty of Rs.25000/- was imposed on the respondent-PIO (Shri Sanjay Kumar). The Judicial Magistrate First Class, Payal was directed to deduct Rs.12500/- each from the salary of Shri Sanjay Kumar, for the months of October, 2018 and November, 2018 and send compliance report after depositing the same in the Government Treasury.

2. The appellant is absent but he has sent an email dated 21.01.2019 with the prayer to exempt him from appearance and supply correct, complete and specific information without further delay.

3. The respondents sent compliance report to the previous order dated 13.09.2018, the contents of which are reproduced below:-

*"In continuation of letter No.5250/E dt. 19.11.2018 on the subject cited, I have the honour to submit that in compliance with the order dt.13.09.2018 passed in Appeal Case No.2155 of 2017, a sum of Rs.12500/- has been deducted from the salary*

*of Sh. Sanjay Kumar, PIO and the amount has been deposited with the District Treasury. Copy of challans showing the deposit is enclosed herewith. It is further submitted that a sum of Rs.12500/- has already been deducted from the salary of PIO and has been deposited with the District Treasury on 15.11.2018. As such the orders have been fully complied with. This is for your kind information.*

4. The representative of the respondents places copies of treasury challans showing the deposit of penalty amount of Rs.12500/- each for the months of October, 2018 and November, 2019. He submits that compensation of Rs.2000/- and complete information has been given to the appellant. He further submits that nothing has been kept pending, which can be given to the appellant as per his RTI application.

5. After hearing the representative of the respondents and going through the record available on the case file, it is revealed that complete information has been given to the appellant and nothing has been kept pending, which could be supplied to the appellant as per his RTI application. They have sent the compliance report to the Commission stating that Rs.25000/- has been deducted from the salary of the PIO and deposited in the Government Treasury and paid compensation amount of Rs.2000/- to the appellant. Accordingly, the instant case is **disposed of** and **closed**. Copies of the order be sent to the parties.
