



The Commission finds that besides the notice issued by the Commission, the respondent PIO has been informed by the office of the D.R.O., Fatehgarh Sahib, on a couple of occasions to look into it and provide the information to the appellant. The original application has been filed by the appellant on 13.08.2018 and despite a lapse of about six months the respondents are showing their ignorance about the application and the notice of the Commission. Apparently, the PIO has rendered himself liable for imposition of penalty. A final opportunity is afforded to him to come in person and explain his conduct. Meanwhile he should ensure that the sought for information is provided to the appellant without fail immediately.
