ORDER

This order may be read with reference to the previous order dated 04.02.2018.

2. Today the appellant states that he has received information pertaining to 62 pages, but misleading and wrong information has been given to him so far.

3. Respondent states that the information, as exists, in the record has been provided to the appellant.

4. After hearing both the parties, it is observed that wrong and misleading information has been given to the appellant so far. The appellant filed RTI with the PIO, o/o XEN, Horticulture on 07.03.2018, but after lapse of more than eleven months, wrong information has been given to him, which shows that the respondent has no regard for the RTI regime.

5. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.2500/- (Rupees Twenty Five hundred Only)** is awarded to the Appellant as compensation. I order accordingly.

6. It is observed that the respondents are being represented by very junior official who are not in a position to satisfy the Commission and the appellant. It is, apparent from the response of the PIO that there has been delay in providing the information.

7. This has resulted in much avoidable inconvenience and hardship to the Appellant. He is, therefore, entitled to be compensated under Section 19(8)(b) of RTI Act 2005 for the loss and detriment suffered by him. In the circumstances, I am of the view that ends of justice would be met if a sum of **Rs.2500/- (Rupees Twenty Five hundred Only)** is awarded to the Appellant as compensation. I order accordingly.

8. This amount shall be payable by the Respondent from the State exchequer within fifteen days from the receipt of this order under intimation to the Commission.
